

The Football Sub-Committee shall fix up the dates and grounds of all games. Games which will be deemed as important by the Sub-Committee will be fixed on neutral grounds. Games of clubs having unfit grounds or having no grounds may be fixed at any grounds at Available or even at the ground of their opponent. In such case, concerned clubs shall concede the "Home facility" advantage. A club failing to provide Home ground (owned or arranged) will not be entertained in the League. Clubs will be responsible for keeping their grounds (whether owned or arranged) in playable condition and in case of their failure to do so, the Sub-committee can take any decision it may deem fit. The decision of the Sub-Committee in respect of fixation of dates and ground shall be final and no claims will be entertained by the DSA. Neither any appeal will lie against the decision of the Sub-committee.

18. Failure to attend ground - In the event of walkover in a game, the absent Team will not earn any points on account of the game, while the Opponent will get/awarded 3(Three) points. If any team fails to participate in 2(Two) games in the league, the name of the team shall be dropped from the Fixture, and the points of their matches will be awarded to their opponents. Such Team (s) will be automatically relegated to next lower division. Disciplinary action may be considered against Teams for wilful and motivated non participation in matches.

In case of such an event, the Club(s) which are yet to play against the concerned absentee club will be awarded (3) Three goals in their favour. It is to be mentioned here that the Club or Clubs that have already played against the concerned Club will be awarded (3) Three goals also in their favour. However, they will not get this advantage if the concerned Club/Clubs score against the absentee team is more than (3) goals.

19. KNOCK-OUT GAMES: For Knock-out games, the following procedure shall be applicable in addition to the ones enumerated above.

(a) In case of drawn games, the penalty shootout method will be adopted via tie breaker method as implemented by DSA.

(b) In the event of both contesting Teams choosing to remain absent on the field on the day of the game, the Football Sub-Committee of DSA will have the option of deciding the position of the Teams as the Sub-Committee deem fit and result thus obtained will be binding on the Teams. In any abandoned games any player is cautioned by referees will be carried forward to Knock-out stages or to any further football games for the sessions 2025-2026.

20. PROTEST IN KNOCK OUT GAMES:



When League games are played on Knock-out basis, protest if any, shall be lodged within half an hour from termination of the game to the authorized representative of DSA or Referee or Ground Authority present on the ground in the Club Letter head with the requisite fees in accordance with League Policy. The protest case may be disposed of on the ground, if necessary.

21. MISCONDUCT :- Each Participating Club is directly liable for the improper conduct of any member of its Official Team Delegation; and/or any person affiliated to it and/or carrying out duties on its behalf throughout the Competition.

Any Participating Player or Official reported for without limitation, any indiscipline or unbecoming or unsporting conduct, violence, or overt act of any nature or conduct amounting to misconduct anywhere including but not limited to the Field of Play, the changing rooms, or otherwise reported by the Referee or the Match Commissioner or any Participating Club or any other person shall be dealt with by the DSA Football Sub Committee in accordance with the applicable Regulations, Code, Guidelines as may be deemed necessary.

22. DISCIPLINARY MATTERS:- A player who has been cautioned by the Referee (shown yellow card or as the case may be) first time, the Sub-Committee shall confirm it and on repetition of the same again on NEXT TWO occasions (i.e. consequence 3 (Three) yellow Cards cautioned), the player concerned shall be debarred from participation in the next game. A player shown Red Card and ordered off the field will be automatically debarred from participating in the next two (2) games. Normally, he will not be required to attend the Sub-Committee meeting. (If any average repeat in Referee's report than Sub Committee with decide to call)

In Case of a player being cautioned TWICE in a game and subsequently ordered off, the concerned player will be automatically debarred from participating in the next game during 2025-2026 session of DSA.

(b) Clubs should be particular about the maintenance of ground specially its marking goal, nets and corner flags, Ground authorities should keep an extra standard Football for meeting emergency and must provide Asst. Referee with flags. Dressing Room facilities must be given to the visiting Team and the Referee. They also should be given other facilities like adequate drinking water, medical facilities etc.

(c) If ground authorities fail to keep the ground ready in time without giving reasonably prior intimation the fixed game on that ground. May be re-fixed on any ground or that may lead to loss of points even depend on Football Sub Committee.



(d) The club is always responsible for the indiscipline conduct of its players, members and supporters failing which serious disciplinary action shall be taken against the club.

(e) Every club must see that the players maintain discipline in the field of play during and after the game. All kinds of dissension and demonstration towards the Referee or the Asst. Referee must be discouraged bearing in mind that such dissension and demonstration may provoke the supporters to be unruly. Severe disciplinary action which may lead to suspension even will be taken against the players and the Team concerned, any report of misbehaviour, jeering, dissension and demonstration against the Referee as well as the visiting team is received. As far as disciplinary actions are concerned, a match started but abandoned will be treated as a game.

(f) All disciplinary measures in relation to the Competition shall be undertaken in accordance with the current DSA Statutes, DSA Disciplinary Code and any relevant DSA guideline, directive or circular as issued by the DSA Football Sub Committee.

The DSA may introduce new disciplinary rules and sanctions during the Competition. Such rules will be communicated to the concerned Club(S) as and when implemented.

a) All Participating Players must agree to respect the spirit of fair play, non-violence, and the authority of the Match Officials;

b) Behave accordingly;

c) Refrain from doping; and

d) Refrain from indulging in Match fixing or corruption.

The DSA Committee, based on the nature of the breach, violation or contravention or compliant, may either on its own or on the basis of any complaint received, initiate investigations and take measures for any breach, violation or non- performance or otherwise in accordance with DSA Statutes, any other relevant regulations, guidelines, decisions or the relevant DSA circular(s) or directions otherwise as per law.

23. POINTS IN LEAGUE GAMES :-

In all Divisions and in each League game Winner shall be awarded 3(Three) points and Loser shall get no point. In case of drawn game each Team will get 1(One) point.

A Participating Club which gives a walkover without sufficient cause to the satisfaction of the DSA or fields an ineligible Participating Player, anytime during the Competition, shall forfeit the Match and the opponent Participating Club shall be declared the winner of that Match and awarded with three (3)



points in addition to award of a three-zero (3-0) score line win in favour of the opponent Participating Club, or the actual score of the Match, whichever is higher.

24. In case of any controversy, discrepancy and inconclusiveness or vagueness, the decision of the Sub- Committee will be final and binding on all participating clubs.
